Free Tuition Application For Senior Citizens

Section 59-111-320 of the *Code of Laws of South Carolina, 1976*, as amended authorizes State-Supported Colleges, Universities and Technical Schools to permit legal residents of South Carolina who have attained the age of sixty (60) to attend classes for credit or noncredit purposes on a space available basis without payment of tuition (excludes required course fees), provided the applicant meets the admission requirements and other standards of the institution, and if these persons do not receive compensation as full-time employees.

Section 59-111-370 of the *Code* provides that any applicant who willfully misrepresents his/her eligibility for the tuition benefits provided for under this act, or any person who knowingly aids or abets such applicant in misrepresenting his/her eligibility for such benefits, shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined not more than one hundred dollars or imprisoned for not more than thirty days.
