### **Other Teaching Activities**

#### Assurance of Learning - Teaching

2010 - Assurance of Learning - Teaching. I am also in charge of the assessment data for the macroeconomics portion of our assessment/learning goals in economics. I wrote the questions for Learning Goals 3 and 4 and asked them on my ECON 301 final exam during both Fall 2009 and Fall 2010. I compiled the results and passed them on to Dr. Weinbach (ECON Assessment Committee representative), Dr. Michael Latta (Associate Dean), and Dr. Barbara Ritter (WCOB Assessment Coordinator).

#### Course (New) - Creation/Delivery: Conventional

2010 - Course (New) - Creation/Delivery: Conventional. I agreed to allow one student (who studied abroad in Paris during Fall 2010) to take ECON 301 as an independent study (although she was on the roster with the remainder of the class). This was highly unusual, given that Intermediate Macroeconomic Theory is a very difficult, theory-driven course. After having discussed the issue with Assistant Dean Darla Domke-Damonte and the student in question, I organized a separate syllabus for the student (see attached). I believe this illustrates my desire to go an extra mile for students in need.

#### Student Assign-Supervised Research (UG)

2010 - Student Assign-Supervised Research (UG). 6 students. In ECON 361, I assigned a semester-long term paper for the third year in a row (having previously done so in ECON 321 for Spring 2008 and ECON 375 for Spring 2009). Students had to select a topic regarding government and fiscal policy, conduct an executive summary and literature review, revise the paper three times, and provide an oral presentation at the end of the term. What makes this exercise unique is that I used the students in Dr. Andrew Weinbach's ECON 302 courses as blind referees for my students' term papers. Upon completion of the final product, I bound everyone's papers into a journal--at my own expense--and gave each student a copy during finals week.

#### Other Teaching Activities

- 2011 Other Teaching Activities. Conducted an international trade exercise in ECON 201 and ECON 301. Students were assigned as buyers or sellers of a good from one of two fictional countries. After two rounds of autarky trading, average prices were calculated in both nations, with the higher cost nation having a higher average price. Once two rounds of international trade were conducted, the law of one price was illustrated.
- 2011 Other Teaching Activities. An extra credit assignment was given to students of both ECON 201 and ECON 301, which awarded points based on a percentage. On the exam, if a student scored higher, he/she received more extra credit points. Students were asked whether they felt such an exercise was fair. This then went into an illustration of the government's imposition of surtaxes.
- 2010 Other Teaching Activities. For both ECON 201 and ECON 202 in summer 2010, I screened the movie 'A Civil Action' to illustrate the impact of negative externalities (in this case, water pollution) on society. On exam days, using the remaining 45 minutes after giving an exam (in order to utilize all available time), I screened for extra credit three episodes of 'Battlestar Galactica' to illustrate various concepts of economic theory: '33', illustrating marginal analysis; 'The Woman King', illustrating scarcity and rationing; and, 'Dirty Hands', illustrating the formation and functioning of labor unions.
- 2010 Other Teaching Activities. In ECON 375, students were assigned as representatives from one of four different countries: Cuba, Iran, the United States, or Russia. During a class period, students discussed the possibilities of imposing or removing economic sanctions on the terrorist-sponsored states of Cuba and Iran.
- 2010 Other Teaching Activities. In ECON 375, DVD clips were used to illustrate the consequences of torture of terrorist suspects in order to gain actionable intelligence (utilitarian arguments vs. moral issues) in a cost-benefit discussion of its use. The movie 'Unthinkable' was also screened to illustrate this concept.
- 2010 Other Teaching Activities. In ECON 361, two episodes from the miniseries 'John Adams' were screened to illustrate the impact of Alexander Hamilton on the Washington Administration, as well as the experiences of the United States during the Quasi-War with France during Adams's presidency.
- 2010 Other Teaching Activities. In ECON 375, students were assigned a 3-4 page debate/discussion paper on whether or not they would approve of the use of torture on someone suspected of terrorism in order to gain actionable intelligence. Upon covering the topic in class, we used a class period to have classroom discussion on the topic.
- 2010 Other Teaching Activities. In ECON 361, I acted as a congressman holding investigative hearings on three different topics: Alexander Hamilton's arguments for a central bank, financing the War of 1812, and

financing the war against the South. Students were assigned one of the topics and divided into groups, where they had to answer rapid-fire questions asked by me in front of an audience comprised of students from my ECON 201 courses.

2010 - Other Teaching Activities. In ECON 201, prior to Spring Break, in an effort to bolster the attendance on the last class meeting before the break, I screened the episode '9:00 AM - 10:00 AM' from the television series '24' for extra credit. The episode illustrated the concept of marginal analysis, in that the U.S. President had to give an immunity agreement to a known terrorist in exchange for the latter's cooperation in trying to save American lives in further suicide bombings. The students overwhelmingly enjoyed the lesson.

2010 - Other Teaching Activities. I allowed two students (one from ECON 201 in Spring 2010 and one from ECON 361 in Spring 2010) to take those respective courses as Honors Program courses. This required assigning both students a book review paper.

2010 - Other Teaching Activities. During Summer 2010, I taught a course (ECO 210--Principles of Macroeconomics) at Horry-Georgetown Technical College. Teaching evaluations are attached.

2010 - Other Teaching Activities. Attached are written comments from students (teaching evaluations, qualitative) regarding courses taught in 2010 at CCU.

2010 - Other Teaching Activities. In ECON 201, I assigned an 'Economic Analysis of a State of the Union Address' for extra credit. I tasked students to study one of the following State of the Union addresses and discuss the economic concepts discussed in the President's speech: FDR, 1937, 1940, or 1941; Kennedy, 1963; Johnson, 1964; Nixon, 1972, 1974; Ford, 1975; Reagan, 1982; Clinton, 1993; George W. Bush, 2001, 2007, or 2008; or Obama, 2010.
