- (1) Students must take a math placement test. MATH 130/130I (with a C or better) may be required prior to MATH 132
- (2) Students have the option to take a foreign language placement test. The results will require either 6 hours of a foreign language in sequence or 3 hours of a foreign language at the 130 level or higher.
- (3) In addition to enrolling in PDA 100: Building Your Business Portfolio every semester, all business majors must complete 9 approved Professional Development Activities (PDAs) as part of their graduation requirement. A list of approved PDAs can be found at www.coastal.edu/business.
- (4) **Please see reverse side for University Core Curriculum.** You will see what classes will satisfy each requirement.
- (5) Completion of CBAD 120 will also satisfy the Global Studies Awareness requirement within the core.
- (6) In order to fulfill prerequisites for upper level accounting classes, **accounting major students must complete CBAD 201 and CBAD 202 with a B average.**
- (7) These are free electives that may be selected from any college of the university including the College of Business (this includes foreign language at the 110, 111, or 120 levels and MATH 130 or 130I).
