(1) Students must take a math placement test. MATH 130/130I (with a C or better) may be required prior to MATH 132
(2) Students have the option to take a foreign language placement test. The results will require either 6 hours of a foreign language in sequence or 3 hours of a foreign language at the 130 level or higher.
(3) In addition to enrolling in PDA 100: Building Your Business Portfolio every semester, all business majors must complete 9 approved Professional Development Activities (PDAs) as part of their graduation requirement. A list of approved PDAs can be found at www.coastal.edu/business.

(5) Completion of CBAD 120 will also satisfy the Global Studies Awareness requirement within the core.
