Course Description

THEA 230 Complete Stage Makeup. (2) This course will introduce the student to the complexities of stage makeup. Utilizing a "hands on" approach, the course is specially designed to require the student to become familiar with basic makeup procedures, complex prosthetic makeup application, and will culminate in the student's application in his or her projects.

Objectives/Overview

- The student will learn the basics of makeup application.
- The student will learn the basics of contouring, blending and color selection as it applies to theatrical makeup.
- The student will experiment with a variety of technical effects.
- The student will apply the techniques learned in class to modify their appearance through a series of projects

Learning Outcomes. Upon Successful completion:

- Students will demonstrate different techniques of application of stage makeup
- Students will demonstrate a proficiency to create a concept for design.
- Students will be able to properly apply stage make-up as presented by the designer.
- Students will demonstrate the ability to create a graphic representation of makeup design for implementation by live performers.
- Students will be able to name the different parts of facial anatomy.
- Students will be able to communicate a character through a series of various makeup projects.
- Students will demonstrate proficiency regarding execution of various application techniques for all types of makeup, including straight, character, and nonrealistic makeup.
