Course Description

GEOG 351 Spiritual Landscapes. (3 credits) (=ANTH 351) In this course, students examine the intersections of geography and anthropology with spiritual beliefs and experiences associated with various landscapes and geologic formations around the world. We discuss the concept of topophilia and the human-environmental connection through the geographies of religion and belief systems. Class case studies include mythology, historical accounts, cultural resource management reports, archeology research, and impacts from tourism. F, S, Su.

Course Objectives:

- Understand geographical and anthropological perspectives regarding various cultural groups' perceptions and beliefs regarding sacred or spiritual lands.
- Explore the academic literature and major research questions within the framework of sacred sites, landscapes connected to belief systems and myths, and the concept of topophilia.
- Use library, web, and other scholarly sources for research.
- Practice critical and communication skills through writing exercises related to topics and research paper.

Student Learning Outcome Goals:

- Explain the application of geographical and anthropological themes and lenses in understanding various cultural belief systems connections to geologic features and landscapes around the world.
- Explain commonalities and differences between different cultural groups world beliefs regarding sacred sites, landscapes connected to cultural belief systems; and topophilia.
- Demonstrate the ability to use library, web, and other scholarly sources for research related to chosen research topic.
- Demonstrate effective critical and communication skills through writing exercises related to topics and research paper.

Required Texts

This course follows a student-focused OER (Open Educational Resources) model, meaning both software and course materials adopted will be at little or no-cost to students in this course. The goal of OER adoption within CCU courses is to reduce total-cost-to-graduation for students while maintaining high quality learning materials for our students. I've carefully evaluated and selected tools and materials that are best-suited for our course, and I hope that you each enjoy learning new tools, using materials that are available at no cost to you, and having the freedoms provided by gaining access to materials that are constantly updated within our discipline. Links to scholarly sources, websites, and videos will be provided in the weekly schedule of activities and within the weekly module folder on Moodle.
