Gene Spivey moved to approve the Academic Excellence and Student Experience Committee meeting minutes from May 3, 2023. Lisa Davis seconded, and the motion carried.

Vice President for University Belonging and Student Affairs, Yvonne Hernandez Friedman presented the UBSA report.

- Student Wellness and Health Equity:
 - Student health and wellness are under one department now to include health, wellness, and counseling.
- Dean of Students:
 - Rolling out a new program, Real Response, which allows anonymous reports

Enrollment and Retention Reports

Hottinger presented the preliminary enrollment and retention reports:

- Freshman enrollment: Up 4.8%
- Transfer enrollment: Up 18.9%
- Total undergraduate enrollment: Up 4.1%
- Total enrollment: Up 3.6%
- First semester retention is 90%
- Fall 22 to Fall 23 first year retention is at 75.8%
