

**MEMORANDUM OF UNDERSTANDING  
REDUCED TUITION**

**FLORENCE 2 COUNTY SCHOOL DISTRICT/COASTAL CAROLINA  
UNIVERSITY**

**SPADONI COLLEGE OF EDUCATION**

This memorandum of understanding is between Coastal Carolina University (CCU) and the Florence 2 County School District. This agreement is offered to partnering school districts who collaborate with the Spadoni College of Education on pre-service and in-service teacher and leadership education initiatives.

Coastal Carolina University agrees to provide a 40% tuition waiver discount of the graduate per credit hour tuition rate in effect for the semester of which the student is registering. Registration is contingent on the student being accepted for graduate study at CCU either as a degree seeking or non-degree seeking graduate student in a program of study that the school district has approved and endorsed. The following qualifications apply:

- a) **Degree seeking graduate student (excludes coursework for the Master of Arts in Teaching (M.A.T.), an initial certification program, and select degree programs where other tuition rates are established).** Students must enroll in approved coursework for a specific degree program.
  
- b) **Non-degree seeking graduate student**  
A maximum of 12 credit hours may be taken as approved graduate coursework to enhance certification. Courses taken in non-degree status may or may not be accepted into a graduate degree program. A maximum of 12 graduate credit hours may be approved for the tuition reduction while in non-degree status.

Qualified participants must have a valid teaching license and be a full-time employee (teacher or instructional personnel) at the Florence 2 County School District. (The Florence 2 County School District will verify names of eligible employees with CCU each semester.)

The 40% waiver must be submitted to the University's Office of Graduate Studies prior to university established fee payment deadlines. Once submitted and approved the waiver will be applied to the student's account. Students are responsible for payment by the due date as indicated on the academic calendar.

This discounted rate will take effect Summer I Semester, 2017. Either party, upon thirty (30) days written notice, may terminate the agreement in whole, or in part.

Coastal Carolina University is a public institution of higher education and is obligated to abide by, and fully comply with, all applicable federal, state, and local laws, rules, and regulations. Florence 2 County School District agrees to fully comply with all applicable federal, state, and local laws, rules and regulations including, but not limited to, the Civil Rights Act of 1964 (as amended in 1991), Title IX of the Education Amendments of 1972, and the Rehabilitation Act of 1973, the Age of Discrimination in Employment Act of 1975, and the Americans with Disabilities Act of 1990.

This specific agreement focuses on the Clinical Field Experiences and Internships that prepare pre-service educators to develop and examine the knowledge, skills, and dispositions relevant for contemporary teaching positions. Clinical field placements follow a scope and sequence of developmentally appropriate experiences from the freshman through senior year that culminates in a specific internship.

This agreement will remain in effect through the 2017-2019 school year and may be modified by a written amendment agreed upon and signed by authorized Coastal Carolina University and Florence 2 County School District representatives.

**Coastal Carolina University agrees to:**

- collaborate with school/district representatives to identify and develop mutually beneficially school/university partnerships
- provide information to the District regarding the types of experiences, the number of students, and the dates and times requested for clinical field experiences.
- provide faculty to assume the responsibility for instructional supervision of the students' clinical field learning experiences.
- communicate with school/district personnel any information that facilitate clear expectations of the clinical field experiences
- provide and maintain the personal records and forms required for students participating in clinical field experiences.
- establish and administer the rules and regulations governing clinical field experiences.
- withdraw any student from the placement at the request of the District for sufficient cause, subject to applicable University policies and statutes.
- assume responsibility for the evaluation of teacher candidates to determine successful completion of degree and/or certification recommendations.
- meet with school/district representatives to review the clinical field experiences at the end of each semester
- provide conference space for teacher candidates, cooperating teachers, and university supervisors to meet for formative and summative debriefing evaluations.
- provide school district personnel with opportunities for professional development that may result in advanced degrees, certifications, endorsements, and licensure renewal.

**Florence 2 County School District agrees to:**

- collaborate with College representatives to identify and develop mutually beneficially school/university partnerships
- provide information to the College regarding the specific placements requested for clinical field experiences.

- provide cooperating teachers to assume the responsibility for instructional supervision of the students' clinical field learning experiences.
- communicate with College personnel any information that facilitate clear expectations of the clinical field experiences
- provide and maintain any records and forms required for students participating in clinical field experiences.
- collaborate with the College to establish and administer the rules and regulations governing clinical field experiences.
- collaborate with the College to withdraw any student from the placement at the request of the District for sufficient cause, subject to applicable University policies and statutes.
- cooperating teachers assume responsibility for the evaluation of teacher candidates during internship
- meet with College representatives to review the clinical field experiences at the end of each semester
- provide conference space for teacher candidates, cooperating teachers, and university supervisors to meet for formative and summative debriefing evaluations.
- permit, upon reasonable request, the review of the clinical and related facilities by agencies charged with the responsibility for accreditation of the University.
- allow access to classrooms to conduct research projects with prior approval by the appropriate personnel in the school system.

### **Reduced Tuition Partnership**

With the above agreement, Coastal Carolina University and Florence 2 County Schools will collaborate to assist district employees to complete select advanced graduate degrees, certificates, and add-on endorsements in coursework offered through the Spadoni College of Education.

In collaboration with the Florence 2 County School District, Coastal Carolina University (CCU) is offering eligible school district personnel the opportunity to register for graduate level coursework taught through the Spadoni College of Education at a payment rate of 40% discount of stated graduate tuition. Teachers and other school district instructional personnel may qualify for the discounted rate if they meet acceptance requirements for graduate study at CCU.

This discounted rate will take effect Summer I Semester, 2017.

### **Cooperating Teacher Compensation**

Cooperating Teachers provide an important service to the education profession by mentoring the future generation of teachers. This is especially significant to partnering school districts in which the internship experience also provides opportunities for preparing potential new faculty. With that in mind, Cooperating Teachers who supervise an internship may elect to receive a non-transferable certificate for one graduate course (value of current graduate tuition), or twenty licensure renewal credits. Cooperating teachers who mentor and supervise clinical field experiences associated with a course may elect to receive a non-transferable certificate for one graduate course (value of current graduate tuition), or twenty licensure renewal credits following two semesters of supervision.

Principals of partnering schools who assist in identifying and placing our teacher candidates for two consecutive semesters may elect to receive a transferable certificate for one graduate course (value of current graduate tuition), or twenty licensure renewal credits.

These compensation agreements will take effect Summer I Semester, 2017. Certificates or renewal credits must be submitted for reimbursement or credit within two years of service completion.
