# PRESIDENT, PROVOST AND OTHER ADMINISTRATIVE REPORTS:

Travis Overton, Chief of Staff:

- The presidential search has passed the first screening process. The Presidential Search Advisory Committee will meet next week to do offsite interviews with candidates. Updates will be posted on the website when they are available.
- Senate Chair, Brian Bunton, added that the applicant pool that The Presidential Search Advisory Committee reviewed consisted of 60% being current presidents or chancellors,

- 37% were current provosts, 11% were current vice presidents, 29% were current deans and 8% were other.

Coastal anticipates a spring or fall public meeting to discuss this.

## Holley Tankersley, Associate Provost:

- There are rumors going around campus regarding the Coronavirus (COVID-19). As of now, the university has suspended study abroad for Spring Break; no decision has been made for Maymester or Summer semester.
- Classes are still on for after Spring Break, but please review the contingency plan that is in place if things do change.
- On March 20, there will be a Beacon Summit and it is open to all faculty. Coastal will begin implementing it this coming fall.
- Provost Ennis is working with the Wall College of Business to find an Interim Dean. The interim will be named in April.
- On March 28, the university will be hosting Town & Gown, which are faculty presentations for community members. It will be from 9 a.m. 4 p.m.
