 - 1. Motion to adopt a Resolution on Mask Mandates at Coastal Carolina University.

Faculty Senator Drew Kurlowski moved to substitute new text in the current resolution as a starting point for discussion. <u>The motion passed by unanimous consent.</u>

Faculty Senator Shari Orisich moved to add additional language to resolution 4: "*until changes in CDC guidelines suggest it is no longer advisable*" and "*with the exception of private residence hall rooms, private workspaces, or while actively eating or drinking inside campus dining facilities*". Kurlowski seconded. The motion passed by unanimous consent.

Faculty Senator Frederick Wood moved the previous question and the previous question moved by unanimous consent. **The motion passed (29 in favor, 21 not in favor).**

The final motion to adopt a Resolution on Mask Mandates at Coastal Carolina University passed (46 in favor, 5 not in favor).
