PRESIDENT, PROVOST AND OTHER ADMINISTRATIVE REPORTS

President Michael Benson mentioned some of the things the Board has been updated on:

- Investments the University has made in faculty and staff over past two fiscal years with decompression, cost of living adjustments, onetime bonus the state has provided, and the tuition benefits.
- Capital projects being worked on such as the Thompson Library and the Arboretum

Benson welcomed a new member to the President's Cabinet, Vice President for Student Affairs, Yvonne Hernandez Friedman.

The Board of Trustees will meet August 11 and 12.

Provost Daniel Ennis presented the Faculty Compensation Plan and discussed the process for faculty decompression. Coastal received \$500k for faculty decompression this year.

Faculty Ombuds, Renee Smith presented annual report which is also on the Ombuds website for CCU.
