What is Staff Senate?

<u>Staff Senate</u> exists to provide a greater representation and voice for the staff of the University and serves as a direct access point between staff and the administration. Over the years, the Staff Senate has helped craft policies that have improved life on campus, and the intent is to continue in this direction. Still in its early years, the hope is that over time the Staff Senate will make a significant impact on the lives of staff and the growth and development of the University.

Upcoming Staff Senate Elections

In March, a call for nominations will go out to fill <u>senate seats</u> that are up for election with terms beginning August 1, 2024. Leading up to the election, the Membership Committee has reviewed current representational groups and the constituents they represent. There will now be 25 representational groups (up from 24) and 30 senate seats (up from 29). Of the 30 seats, 13 will be up for election this year.
