Hotel, Condo-Hotel, and Campsite Properties

Preliminary results from Coastal Carolina University's voluntary sample of hotel, condo-hotel, and campsite (HC-HC) properties along the Grand Strand during the week of Aug. 23-29, 2020, are shown below.

# **Reservation Level Estimates**

Vacation Rental Properties

Based on the Brittain Center's observations of random samples of internet websites of vacation rental properties (VRPs) in the coastal sections of Horry and Georgetown counties (448 of the 4,927 units) for which complete data is publicly available, the percentage of properties that are reserved or blocked from further reservation at this time are shown below, as well as the revised estimates of the percentage blocked during the equivalent rental week last year.

## **Forecasts and Analysis**

The center's researchers are monitoring the percentage of VRPs blocked as reserved on the internet between Aug. 22, to Nov. 13, 2020 (above). The final results four days in advance of the date of arrival for each of the equivalent rental weeks in 2019 are also shown. Average occupancy and reservations results are available graphically at the center's <u>research website</u>.

According to weather.com at the time of this writing, the weather forecast for the weekend of Sept. 5-6, 2020, calls for a high temperature of 87 degrees and 83 degrees, respectively, and 20 percent chance of precipitation on both days. The Brittain Center now predicts that average occupancy for its sample of HC-HC properties and may be near or above 85 percent for the Memorial Day weekend of Sept. 4-6, 2020.

## **July Results**

Current results for Brittain Center's voluntary sample of HC-HC properties located along the Grand Strand and the final results of researchers' internet observations of a scientifically random sample of VRP websites in Horry County are shown below. # **Additional Research Notes**

The Brittain Center's preliminary sample of 12 HC-HC properties reporting for the week of Aug. 23-29, 2020, was 4,059 units consisting of five hotels, six condo-hotels, and one campground resort. During the most recent 52-week period, the center's sample of all hotels, condo-hotels, and campsites averaged 5,773 units per week.
