Hotel, Condo-Hotel, and Campsite Properties

Preliminary results from Coastal Carolina University's voluntary sample of hotel, condo-hotel, and campsite (HC-HC) properties along the Grand Strand during the week of Nov. 22-28, 2020, are shown below.

Vacation Rental Properties

Based on the Brittain Center's observations of stratified random samples of internet websites of vacation rental properties (VRPs) in the coastal sections of Horry and Georgetown counties for which complete data is publicly available, the percentage of properties that are reserved or blocked from further reservation at this time are shown below, as well as the revised estimates of the percentage blocked during the equivalent rental week last year.

Forecasts and Analysis

The center's researchers are monitoring the percentage of VRPs blocked as reserved on the internet between Nov. 21, 2020, and Feb. 12, 2021 (above). The final results four days in advance of the date of arrival for each of the equivalent rental weeks in 2019 are also shown. Average occupancy and reservations results are available graphically at the center's <u>research website</u>.

According to weather.com at the time of this writing, the weather forecast for the weekend of Dec. 5-6, 2020, calls for a high temperature of 58 degrees and 53 degrees, and an 18 percent and 3 percent chance of precipitation, respectively. The Brittain Center now predicts that average occupancy for its sample of HC-HC properties may be near or above 40 percent for the weekend nights of Dec. 4-5, 2020.

October Results

Current results for Brittain Center's voluntary sample of HC-HC properties located along the Grand Strand and the final results of researchers' internet observations of a scientifically random sample of VRP websites in Horry County are shown below. The Brittain Center's preliminary sample of 9 properties reporting for the week of Nov. 22-28, 2020, was 3,147 units consisting of four hotels, 4 condo-hotels, and one campground resort. During the most recent 52-week period, the center's sample of all hotels, condo-hotels, and campsites averaged 4,800 units per week.
