Course Description

SOC 430 Hate Crimes (3 credits) (Prereq: SOC 101 or SOC 102 and junior or senior standing or instructor consent) Hate Crimes is the study of bias-motivated crimes in the United States. The course provides an overview of the sociopolitical contexts of hate crimes, typologies of motivations, protected groups, and victim experiences. Students also gain an understanding of hate crime legislation and explore theories of hate as a sociological and criminological concept. F, S

Course Objectives

- Demonstrate critical thinking skills related to bias-related crimes, including motivations, typologies, and solutions.
- Effectively communicate in writing and orally.

Student Learning Outcomes

- Legally define hate crimes.
- Give a theoretically informed definition of hate as emotion and action.
- Explain typologies of the motivations that accompany hate crimes.
- Describe the legislatively protected categories of hate crime victims.
- Argue effectively in support of or against designating specific incidents as a hate crime.
- Describe the characteristics of hate groups.
- Describe the characteristics and motivations for those who join hate groups.
- Discuss attempts to curb hate crime incidents and argue for solutions that will work to eradicate hate.
