### **SUMMARY:**

Students who are placed on academic probation, as defined in the Coastal Carolina University Catalog, must complete the requirements set forth by their academic college in addition to the requirements that are listed in the Coastal Carolina University Catalog. Modifications to college specific policies must be approved by the Academic Affairs Committee, Faculty Senate and the provost.

#### **POLICY:**

#### I. POLICY

Students who are placed on academic probation, as defined in the Coastal Carolina University Catalog, and have earned 30 or more credit hours must complete the requirements set forth by their academic college in addition to the requirements that are listed in the Coastal Carolina University Catalog. Failure to complete these requirements in the semester in which they are assigned could result in a student remaining on academic probation, regardless of their earned cumulative GPA. Students who have earned less than 30 credit hours and are on academic probation must comply with ACAD-140. College-specific policies are developed by the Office of the Dean of each academic college. Modifications to college-specific policies must be approved by the Academic Affairs Committee, Faculty Senate and the provost.

### A. Wall College of Business

Business students who have earned 30 or more credit hours, including all business majors, pre-majors and undeclared business majors, and are placed on academic probation must complete the following college specific requirements:

- 1. Attend an Academic Success Seminar, in-person or virtual, conducted by a representative of the Dean's Office.
- 2. Complete UNIV 105: *Academic Improvement Hour*. Students will be automatically registered for this zero-credit course.
- 3. Meet with the Director of Student Success and Transition at least one time per semester for each semester on probation.

# B. Spadoni College of Education and Social Sciences

Education and Social Science students who have earned 30 or more credit hours, including all majors, pre-majors, and undeclared majors, and are placed on academic probation must complete the following college specific requirements:

- 1. Attend an Academic Success Seminar conducted by a representative of the Dean's Office.
- 2. Meet with the Student Success Coordinator at least one time per semester for each semester on probation. Additional meetings may be required as established by the Dean's Office and the Student Success Coordinator.
- 3. Participate in at least two College Student Success Workshops for each semester on probation. The Student Success Coordinator will contact the student.

## C. Edwards College of Humanities and Fine Arts

Humanities and Fine Arts students who have earned 30 or more credit hours and are on academic probation must complete the following college specific requirements:

- 1. Meet with the Director of Student Success, Recruitment, and Career Transition at least one time per semester for each semester on probation.
- 2. Complete HFA 133: *Academic Mindset for Success* with a grade of C or better. Students on probation who have taken HFA 133 in a previous semester but did not earn a grade of C or better must register for HFA 133.

## D. Gupta College of Science

Science students who have earned 30 or more credit hours and are placed on academic probation must complete the following college specific requirements:

1. Complete a GCOS academic success workshop conducted by a representative of the Dean's Office.

2. Meet with the Director of Student Success & Persistence at least one time per semester for each semester on probation..

In addition, student are encouraged to enroll in UNIV 105S: *Academic Improvement Hour*.

# E. CMC College of Health and Human Performance

Health and Human Performance students who have earned 30 or more credit hours and are placed on academic probation are encouraged to complete the following college specific requirements:

- 1. Attend an Academic Success Seminar, in-person or virtual, conducted by a representative of the Dean's Office.
- 2. Complete an individual Action Plan via Moodle as outlined by their assigned Academic Success Advisor.
- 3. Meet with their assigned Academic Success Advisor at least one time per semester for each semester on probation.

# F. HTC Honors College

Honors students who have earned 30 or more credit hours and are on academic probation must complete the following college specific requirements:

- 1. Attend an Academic Success Seminar conducted by a representative of the Dean's Office.
- 2. Encouraged to enroll in UNIV 105: Academic Improvement Hour.

## G. College of Graduate & Continuing Studies

Bachelors of Professional Studies students who have earned 30 or more credit hours and are placed on academic probation have no additional requirements beyond university policy.
