



# Pool Rental Policies and Procedures Coastal Carolina University Aquatics Center

Please read and understand the following rules and regulations prior to your pool rental. If you have any questions please contact the aquatics department at any time, or ask an aquatics staff member. We hope you enjoy your pool rental!

## Posted Pool Rules and Regulations:

- There should be no running, boisterous or rough play.
- All patrons must wear appropriate swimming attire.
- **There should be no food on the pool deck.**
- No person under the influence of alcohol or drugs should use the pool.
- There should be no spitting or blowing nose in pool.
- Persons with skin, eye, ear or respiratory infections should not enter the pool.
- Persons with open lesions or wounds should not enter the pool.
- Persons with diarrheal illness or nausea should not enter the pool.
- No animals or pets allowed in the pool.
- **No glass allowed in the pool or on the deck.**
- No children should be in the pool without supervision.
- You should take a shower before entering the pool.
- No diving allowed in the shallow end. Diving is permitted in water 9 ft. or deeper.
- **No children should be in the pool without supervision.**
- Campus Recreation reserves the right to prohibit usage for anyone who violates departmental policies.

## Proper attire:

- Proper swimming attire is required. Cut off pants and denim fabrics are prohibited.
- **Street shoes are not permitted on the pool deck. Deck shoes only.**
- Attire that has been worn for exercising immediately prior to pool use should not be worn in the pool.
- All infants/toddlers that require a diaper must wear swimmer diapers and proper swimwear.
- **Only US Coast Guard-Approved flotation devices are permitted in the pool. No inflatable flotation devices please.**

## Behavior:

- Proper behavior is required. Any activity deemed unsafe will be prohibited.
- **Please do not play on the pool ramp, this is for entering and exiting the pool only.**
- Swimming over and hanging on lane lines is prohibited

- Prolonged underwater swimming for time, distance or competition is prohibited. These activities are extremely dangerous and are not permitted.

**Prohibited items:**

- Toy balls of any kind
- Inflatable floatation devices
- Mermaid fins or leg sleeves
- Rafts of any kind
- Squirt guns

**Groups:**

- Group rentals need to be set up and approved by the aquatics coordinator prior to the event.
- All swimmers must pass a swim test to swim in the deep end of the pool
- All pool rules, policies and procedures apply to groups and parties.
- **Swimmers must be supervised at all times (parent, councilor etc.)**
  - For every 10 swimmers you must have one accompanying adult.
  - Children under the age of 5 years old should have an accompanying adult in the water.
- **Groups will enter and exit the facility from the pool patio (glass doors).**
- **Users must stay in the pool area at all times. The outside pool patio is also available for use.**
- The group representative must provide a roster of all attendees upon entrance to the facility prior to each use.
- We reserve the right to deny any group future admittance to our facility if any member of a group causes the pool to close due to defecation in the pool.
- Locker rooms must be used under strict supervision at all times. We reserve the right to refuse the use of our locker rooms if destruction occurs.

**Inclement weather:**

- In the event of inclement weather the pool will closed.
- The pool will re-open once the inclement weather has cleared the area at the discretion of the Aquatics Staff.
- The pool may be temporarily shut down due to defecation in the pool, or irregular pool chemistry.
- In any pool closing event, lifeguards will clear the pool as well as the pool deck until re opening is permitted.
- We will make all efforts to notify your group of a pool closure prior to your arrival, if possible.
