- A. Faculty Senate Executive Committee
 - 1. Motion to modify policy ACAD 109: New Program Modification and Development. **The motion passed (43 in favor, 1 not in favor).**
- B. Academic Affairs Committee
 - 1. College of Business programs impacted by the recent college-level approved changes to the Business Foundation Core. The motion passed (44 in favor, 4 not in favor).

NEW BUSINESS:
