This committee oversees and makes recommendations regarding all aspects of the core curriculum, including implementation, modification, and assessment. The committee's recommendations regarding modifications to core curriculum requirements are forwarded to the

Academic Affairs Committee for approval prior to requesting senate action. The committee reviews and makes recommendations on all student petitions regarding the core curriculum. The director of the Core Curriculum is responsible, in conjunction with the Office of Institutional Research and the Core Curriculum Committee, for ensuring effective ongoing development, implementation, and assessment of the Core Curriculum. The director of the Core Curriculum reports this data and Core Curriculum recommendations to the University-wide Assessment Committee.

Core Curriculum Assessment and Recertification:

- Core Curriculum Assessment communication continues to be an issue that the committee continues to discuss. Departments are missing core assessments due to lack of collecting data as well as reporting partially due to communication issues from various sources.
 - Director of Core Curriculum indicated that the necessary information

for core assessment each year would be communicated to necessary departments through chairs and core assessment representatives with the expectation that departments would then communicate to the necessary people within the department.

- People were directed to the Moodle resource site – Core Petitions and Assessment for a direct source of information.

- Core Curriculum Assessment Data Reporting by Core Goal in CampusLab
 - IC – Communication Across Cultures
 - IIB – Human and Social Behavior

- Review of Core Professional Development Grants
 - Provided advise and feedback on the call for funding of the newly developed Core Professional Development Grants. A subcommittee of one member from every college aided in the review of appliactions submitted and provided recommendations to the Associate Provost to make final funding decisions.

- Committee's review of Core Curriculum Assessment Plans and Recertification
 - Protocols for review of recertification was discussed
 - Core Goal IA and IID course recertifications reviewed and approved
 - Discussion of determining a specific rubric and exemplars for the process
 - Director assigned plans and recertification worksheets to the committee members for review.
 - Members provided an assessment of assigned plans and worksheets to the committee for approval.

- Committee reviewed and provided feedback and recommendation on the selection of a new Director of Core Curriculum to the Associate Provost.

Core Curriculum Action Items:

- Blanket Substitution Approved Requests
 - Approval of a blanket petition to ECON*202 Microeconomics to fulfill Core Goal IA Critical Thinking and Reasoning for the catalog years 2017 and later.

 - Approval of a blanket petition for THEA*495A (Theatre Internship) or THEA*495B (Theatre Internship), when taken as 15 credits that include one semester of Italian I and one semester of Italian II at the Accademia dell'Arte in Italy, will meet expectations of Core Goal IC Communication Across Culture..
 - need to take both Italian I and Italian II to meet this goal
 - Once the student has completed the coursework, they will need to work with their advisor to submit a Course Substitution form to the

Director of Core Curriculum for review and a signature.

- Approved the continued generation of a recommendation list for transfer courses that would automatically meet a Core Goal
 - IF previously approved by the Core Curriculum Committee through an Exception to the Core petition
 - Courses only approved for 4 years after the petition approval to follow same recertification timeline for CCU courses
 - Not sure if this process has been implemented by the registrar
