

## NON-RESIDENT TUITION FEE WAIVERS

*Waiver of Non-Resident Tuition Fee for Sister State and Designated International Special Cooperative Zones*

Applicants to Coastal Carolina University who are a citizen/resident of a country or constituent country that has a special relationship with South Carolina enables you to be awarded a waiver that will provide a substantial reduction in the costs associated with attendance at Coastal Carolina University.

Based on 2023-2024 tuition rates, the **value for undergraduates** for which the non-resident tuition waivers are approved is **\$17,988 (enter this amount on your Financial Statement in your International Student portal)** for the academic year, reducing tuition and fees paid to equal \$11,640 before any special program fees. For **graduate students**, the value of the waiver is **\$10,674 based on 9 hours per semester (enter this amount on your Financial Statement in your International Student portal)** for the academic year, reducing tuition and fees paid to equal \$10,764 before any special program fees. This waiver will continue as long as you make satisfactory progress toward your academic degree, and your country remains a location for which the non-resident tuition waivers are approved. **If approved, students must maintain immigration requirements for in-person class attendance (if applicable) to remain eligible for this waiver. The waiver can be applied during either the fall, spring, or summer semester.**

If you elect to enter Coastal Carolina University under one of these non-resident tuition waivers, students will **NOT** be eligible to receive further incoming merit/academic-based international scholarships.

### REQUIREMENTS FOR VERIFICATION FOR THE NON-RESIDENT TUITION WAIVER FOR STUDENTS FROM APPROVED SISTER STATES

The State of South Carolina has approved a limited number of sister-state agreements that enable students who have citizenship and residency in the respective areas to receive the non-resident tuition waiver outlined above reducing their tuition at Coastal Carolina University to the in-state tuition rate.
